Guided tours may take place in Heidelberg (subject to changes) under the following conditions.

Please note the opening hours of the tourist information at Neckarmünzplatz: Monday to Thursday and Saturday 9.30 a.m. to 5 p.m., Friday 9.30 a.m. to 6 p.m and on Sunday and public holidays 10 a.m. to 3 p.m. The tourist information at the Main Station is open from Monday to Saturday 10 a.m. to 5 p.m and on Sunday and public holidays 10 a.m. to 3 p.m.

- Reduced group size: Guided tours with a maximum number of 19 guests per guide.
- Face masks: FFP2 or medical mask requirement does not apply during an outdoor tour.
- Please note that in case of booking a city and castle sightseeing tour by bus, a mask is also mandatory during the bus tour. It is not possible to attend a bus tour without wearing a medical mask.
- Please note that in some indoor areas and museums, masks could be still mandatory according to house rules.
- We recommend to wear also a mask in narrow passages and wherever the minimum distance can not be maintained.
- We recommend to observe the minimum distance (from person to person: 1.5 m 2 m) and the current hygiene measures.
- Visitors are kindly requested to register in advance for the public tours.
- Cashless payment is possible by paying on site at the tourist information for public tours. The tourist information provides a guidance system to show visitors the way. Further protective measures such as protective screens or floor markings as well as disinfectant dispensers have been implemented.
- Specific guidance of visitors through the expertise of the tour guides, in order to avoid crowds.
- Heidelberg Castle: It is still mandatory to wear a FFP2 face mask, for persons under 18 years of age, it is still mandatory to wear a FFP2 face mask or medical mask in indoor areas.
- **Funicular railway:** It is still mandatory to wear a FFP2 face mask, for persons under 18 years of age, it is still mandatory to wear a FFP2 face mask or medical mask.
- Friedrich-Ebert Gedenkstätte: It is still mandatory to wear a FFP2 face mask.
- Student prison and University Museum: It is still mandatory to wear a FFP2 face mask or medical mask.

If you show any symptoms of illness, we kindly ask you to cancel your booking on time.
